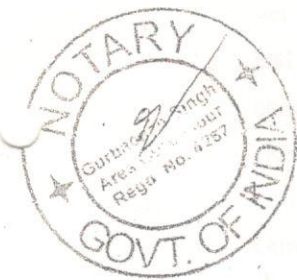

2. The study of Punjabi Language upto Matric Level in your school will be compulsory and C.B.S.E. New Delhi will take steps to to arrange the Examination of Punjabi compulsorily in such schools At the same time it is also stated here that in case of not doing so, the No Objection Certificate will immediately be taken back.
